1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Audit opinion – Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters which although not material to my opinion, should be addressed by the Council:

Incorrect treatment of unrepresented cheques

The Council has not properly accounted for unrepresented cheques and has stated these are year end creditors (line 10). The accounts must not be amended for cheque payments made before the year end that only clear the bank account in the new year. The expenditure is properly reported when the cheque is issued. The Council's error means that lines 9 and 10 are overstated by £210. Although this is not material and does not affect the carried forward balances the incorrect treatment risks creating accounting errors in future years.
